Exhibit 32: State Laws and Regulations

This Exhibit will track the requirements of proposed Stipulation 32, dated August 26, 2019, and therefore, the requirements of 16 NYCRR § 1001.32. Policies and guidelines are addressed in Exhibit 4.

32(a) State Approvals, Consents, Permits, Certificates, or Other Conditions of a Procedural Nature

The Applicant has compiled a list of state approvals, consents, permits, certificates, or other conditions of a procedural nature that are applicable to the construction or operation of the Project (see Table 32-1 below). These state requirements are supplanted by Public Service Law (PSL) Article 10 unless the Board expressly authorizes the exercise of such authority by the state agency.

In addition to the Article 10 Application, the Applicant will apply to the NYPSC for a Certificate of Public Convenience and Necessity Pursuant to Section 68 of the PSL authorizing the exercise of municipal rights to occupy municipal property and for other authorizations as clarified by the NYPSC staff in its Cassadaga decision issuing the certificate.

32(b) List of State Procedural Requirements

At this time, the Applicant does not request the NYPSC staff to authorize any state agency to expressly authorize the exercise of authority for any procedural requirements.

32(c) State Approvals, Consents, Permits, Certificates, or Other Conditions of a Substantive Nature

The Applicant has compiled a list of state approvals, consents, permits, certificates, or other conditions of a substantive nature that are applicable to the construction or operation of the Project (see Table 31-2 below).
